

End-User Software License Agreement

Please read this agreement carefully before purchasing, installing, copying, downloading, or using BI4Dynamics software. By installing, copying, downloading, or using BI4Dynamics's software, Licensee agrees to be bound by the terms of this limited use license.

This end user software license agreement ("AGREEMENT") is a legal agreement between "Licensee" (the individual or entity) who acquired or subscribed to the BI4Dynamics software products and documentation (collectively, "Software,") accompanying this AGREEMENT and BI4 DYNAMICS UK Ltd, ("BI4DYNAMICS"). By installing, copying, downloading, or using the Software, Licensee agrees to be bound by the terms of this AGREEMENT. If Licensee does not agree with the terms of this AGREEMENT, BI4DYNAMICS is unwilling to license the Software to Licensee. In such event, Licensee may not install, copy, download or use the Software and Licensee must uninstall complete Software package within thirty (30) days.

1 LICENSE

Grant. Subject to the terms and conditions of this AGREEMENT, BI4DYNAMICS hereby grants to Licensee a non-exclusive, non-transferable license to use the Software for internal business purposes only and only on the authorized number of Microsoft Dynamics databases and modules for which Licensee has paid Reseller or BI4DYNAMICS a license fee.

Term. The license granted hereby begins upon your acceptance of these terms, as evidenced by your installation, copying, downloading or use of the Software and continues in perpetuity unless terminated sooner in accordance with section 5 "Termination".

No Copies. Except as expressly allowed by the terms of this license, Licensee shall not copy any portion of the Software other than that Licensee may make one (1) copy of the computer program portion of the Software solely for archival purposes.

Other Limitations. Licensee shall not:

- Distribute, disclose, market, rent, lease or transfer to any third party any portion of the Software, or use the Software in any service bureau arrangement, facility management or third-party training.
- Export, re-export, or otherwise transmit, directly or indirectly, any software, information, data, or other materials received under this Agreement.

Hardware and/or Third-Party Software. BI4DYNAMICS will not be responsible for the acquisition of any third-party hardware and/or software required for the use of the Software to meet Licensee's required use for the Software. Licensee undertakes that any such required hardware or software will be purchased (if at all) by Licensee on its own account. Licensee agrees that it, and not BI4DYNAMICS, has the obligation to investigate to ensure that the Software meets the Licensee's needs and specifications, and is compatible with the Licensee's third-party hardware and software.

2 OWNERSHIP & CONFIDENTIALITY

Title. Title to the Software is reserved to BI4DYNAMICS. Licensee acknowledges and agrees that BI4DYNAMICS is and will remain the owner of the Software and the content thereof and the ideas and concepts embodied therein, and in all copies, modifications, alterations and enhancements to the Software, including any derivative works resulting therefrom.

All rights and licenses granted by BI4DYNAMICS under or pursuant to this Agreement, to Licensee, are personal, and shall otherwise be deemed to be licenses to rights to intellectual property.

The Software was developed at private expense, is commercial, and is published and copyrighted.

Proprietary Information. Licensee agrees that the Software and all computer code, inventions, algorithms, know-how and ideas embodied in or by the Software and all other business, technical and financial information Licensee obtain from BI4DYNAMICS, whether designated confidential or not (hereinafter referred to as "Proprietary Information") are the property of BI4DYNAMICS and are confidential. Licensee also agrees that any expression of BI4DYNAMICS's analyses, conclusions, enhancements, opinions, designs, recommendations, ideas, techniques, know-how, findings, software, and other technical information provided to Licensee by BI4DYNAMICS while performing consulting, training, maintenance or other services related to the Software are the Proprietary Information of BI4DYNAMICS and are confidential.

Non-Disclosure. Licensee agrees to keep the Proprietary Information in a secure place, under access and use restrictions designed to prevent disclosure of the Proprietary Information to unauthorized persons and to instruct Licensee's personnel to keep the Proprietary Information confidential.

Breach. Licensee agrees that any disclosure of the Proprietary Information to a third party other than in accordance with the terms of this AGREEMENT constitutes a material breach of this AGREEMENT and will terminate the license granted by this AGREEMENT.

Injunctive Relief. Licensee further agrees that Licensee will be liable for all damages to BI4DYNAMICS that result from any wrongful disclosure of the Proprietary Information to any third party. Licensee acknowledges that such wrongful disclosure could cause irreparable injury that cannot be compensated by monetary damages and that injunctive or other equitable relief may be appropriate, and that it shall not demand, or ask any court to impose, any undertaking regarding damages or bond as a condition of BI4DYNAMICS obtaining equitable relief.

3 ENHANCEMENT PLAN

For End Users who use the Products on a subscription basis, the Enhancement plan is included in the subscription. In this case the Enhancement is provided to End Users by subscription periods.

Enhancement plan for Products is mandatory for the first year of purchase. Enhancement fee is 16 % of Products license value (Recommended Retail Price).

Enhancement plan includes:

- Product Updates
- Bug fixes
- Documentation Updates

BI4DYNAMICS provides hot fixes only for bugs in unaltered BI4Dynamics Products that were delivered by BI4DYNAMICS to End Users or to RESELLER.

For bug fixes on altered BI4Dynamics Products is responsible End-User. BI4DYNAMICS assures support for bug fixes on altered BI4Dynamics Products upon Payment that will be defined for each issue.

BI4DYNAMICS is not responsible and gives no warranties or guarantees for front-end BI tools that will Licensee use for data presentation and analysis. They are subject to their manufacturer license terms.

Before BI4DYNAMICS can begin work on any problem, information on the nature and location of the problem is required. Whenever an error report or call is placed, the following information should be provided:

- Licensee Company Name, Contact Person
- Licensee Contact Person's phone number and email address
- Any program error messages associated with the problem (screen captures would be helpful)
- A detailed description of the problem
- Any steps you have taken in attempt to solve the problem

Enhancement is provided in annual support periods. Initial-year annual Enhancement for BI4Dynamics products commence on the date of purchase of the BI4Dynamics products. Thereafter, Enhancement may be renewed for successive periods of one year.

BI4DYNAMICS tries its best to notify the Licensee through RESELLER of renewal information prior to the date for renewal of Enhancement. Related fees are due and payable annually in advance of commencement of the applicable Enhancement Period. Failure to pay Enhancement fees will result in suspension of Enhancement Services and reinstatement fees will apply.

If the Enhancement Plan lapse, have not been renewed or were never originally procured, a Reinstatement Fee shall be assessed upon re-commencement of the Annual Service Pan equal to the amount of the Enhancement fees for the period of lapse plus the annual renewal fee, calculated based on the current Enhancement fee in effect at the time of reinstatement.

Customization and development wizard (Wizard) functionality is related to active Enhancement plan. The Wizard will work only during the period for which the Enhancement plan was paid. The expiration of Enhancement plan will result in disabled Wizard features. However, the SQL and XML scripts that have been generated by Wizard before the expiration, will still be available.

No free upgrade or any other services are included in Enhancement plan.

4 WARRANTIES AND LIMITATIONS OF LIABILITY

BI4DYNAMICS warrants that the medium on which the Software is delivered will be free from defects in workmanship and materials under normal use for a period of sixty (60) days after delivery of the Software, and that the medium will be repaired or replaced, or Licensee's purchase price refunded, at BI4DYNAMICS's option, upon return of said defective medium to BI4DYNAMICS within said sixty (60) day period.

No Warranty. THE SOFTWARE IS PROVIDED "AS IS." BI4DYNAMICS AND ITS SUPPLIERS DO NOT WARRANT THE PERFORMANCE OR RESULTS LICENSEE MAY OBTAIN BY USING THE SOFTWARE. STATEMENTS BY BI4DYNAMICS AND ITS EMPLOYEES OR REPRESENTATIVES AND THE PRINTED MATERIALS AND ELECTRONIC DOCUMENTATION THAT ARE PART OF THE SOFTWARE DO NOT CONSTITUTE A WARRANTY OR REPRESENTATION THAT THE SOFTWARE WILL PERFORM AS DESCRIBED IN THOSE MATERIALS.

5 TERMINATION

BI4DYNAMICS may terminate this AGREEMENT if Licensee commits a material breach of this AGREEMENT, and such breach is not cured within thirty (30) days of receipt of a written notice of such breach. Upon termination of this AGREEMENT, Licensee will immediately destroy or return to BI4DYNAMICS all Software and Proprietary Information in his, her or its possession. By installing, copying, downloading, or using of the BI4Dynamics software the user agrees that the subscription is automatically renewed for the same subscription period, if not canceled 14 days before the end of the current period. Termination of subscription shall be reported to sales@bi4dynamics.com.

6 GENERAL TERMS AND CONDITIONS

Severability. If any provision of this AGREEMENT is found by any court of competent jurisdiction to be invalid, then it shall be read as narrowly as is necessary by court to permit it to be enforceable, and the remaining provisions shall nevertheless remain in full force and effect.

Governing Law; Jurisdiction; Attorneys Fee. This AGREEMENT shall be governed by the laws of the United Kingdom and the parties hereby consent to jurisdiction and venue to be chosen at the discretion of BI4DYNAMICS. If any legal action is necessary to enforce the terms of this AGREEMENT, the prevailing party shall be entitled to reasonable attorney's fees and costs in addition to any other relief to which that party may be entitled.

Entire Agreement. Licensee acknowledges and agrees that this AGREEMENT is the entire and exclusive statement of the mutual understanding of the parties and that it supersedes and cancels all previous written and oral agreements and communications relating to the subject matter of this AGREEMENT. Licensee agrees that this AGREEMENT can be modified only by an agreement in writing signed by the persons authorized to execute agreements on behalf of the parties hereto, which in the case of BI4DYNAMICS excludes third parties. No modification can be accomplished by course of conduct.

No Waiver. Licensee agrees that any failure or delay to exercise or any partial exercise of any right, power, or privilege hereunder by BI4DYNAMICS shall not operate as a waiver.

Export Laws. Licensee shall comply with all then current export laws and regulations of the government of the country in which Licensee receives delivery of the Software, which pertain to the Software.
